Re: Rating of Commercial Paper programme of Biocon Limited

This is in reference to the rating action commentary released on 22 January 2025.

India Ratings and Research (Ind-Ra) is pleased to communicate the rating of 'IND A1+' for the INR12 billion Proposed Commercial Paper Program of Biocon Limited.

In issuing and maintaining its ratings, India Ratings relies on factual information it receives from issuers and underwriters and from other sources India Ratings believes to be credible.
